LIBRARIANS REPORT -

- We have been open 48 days in 2021 with 12 new patron cards issued.
- Closed early Feb 15 due to weather.
- ILF on demand sessions complete
- ft Adult reading club going well, require signup to participate in activity.
 - Staff picks video of favorites to recommend. Posting on Facebook and web site. Getting really good feedback. Will continue one per month instead of newsletter
 - 2nd virtual concert had 223 watching. Disney musicals this week, expect a good response.
 - Lego club doing well since offering a prize for challenge. March is a rainbow.
 - Ordering and book reviews have been hard to keep up with.
 - Baker and Taylor orders are delayed still. Having trouble with jacket gluing, thesaurus arrive unbound from book.
 - Wowbrary signups 71 signed up at start. Now 91, sending to 744 email addresses, so looking for ways to increase signups. Signing up all 744, and they can unsubscribe if they don't want.
